With our recent change in management, I want to briefly outline our goals to strengthen the Company for the future.

The wood products industry is going through a major period of manufacturing and marketing realignment that will require us to operate at top levels of efficiency to meet the challenge of new competition. Industry "analysts" speak of a shakedown period in which some manufacturing plants will be curtailed in production and others closed. I want to assure you that we firmly intend to continue the long term operation of our mills.

With this in mind, we will focus on the basics required to keep ourselves in the top tier of wood product manufacturers. These basics are <u>Production</u>, <u>Recovery</u> and <u>Quality</u>, at all levels of manufacture, from the tree to the market. We want to improve performance in each of these areas. Raw material and manufacturing costs will come down as we improve. We must be consistent in our gains.

We will continue to seek, purchase and deliver quality raw materials for our mills at good competitive prices. And, we will continue to demand fair prices for our raw material by-products.

At the same time, we will lower our General and Administrative costs as much as possible. Changes will be made now and during the next few months. Also, we will work to lower our General Overhead costs in the same manner. We must practice thrift and economy at all levels of production and management in a way that does not hinder production, recovery, or quality of our products. We want to continue to be a quality, low cost producer of wood products.

We will also be hard at work to improve our salesto-plant relationships, and to improve our sales-to-customer relationships. These relationships are a "must" and are an immediate goal. At the same time, we will be seeking new products for us that will help to improve our profit margins. We have the flexibility to make new products as long as they are priced to improve our margins.

I look forward to working with you to strengthen our Company now and to plan for the future.

The Management Information Systems (MIS) Department is responsible for supporting all of the computer systems at Hunt Plywood Company. The following will help to convey the size and scope of the Hunt Plywood computer operations.

During the first half of 1996, the MIS Department completed work on the plants' on-screen production reports, the production downtime system, and installed the quality control software in Natalbany. These systems are working well and helping the plants to track their operations. We are looking forward to continuing installation and enhancement of the plant production systems.

The MIS Department is working in conjunction with the Accounting, Payroll, HR, Sales, and AR/AP Departments to upgrade the J.D. Edwards accounting system from version A5.2 to version A7.2. This upgrade is necessary to insure that the accounting software will work properly in the next century and to take advantage of new features which our software supplier has added to the system. This project was started on May 6th and will be completed by Labor day of this year. Many of MIS's other projects and duties have been put on hold until this project is complete. WOODLANDS

During the late summer and fall of the year, it is common to see large smoke plumes rising into the atmosphere. These smoke plumes are usually the result of a prescribed or control burn being conducted by a landowner to prepare an area for regeneration.

Prescribed burning is the controlled application of fire to wildland fuels under specified environmental conditions which allow the fire to be confined to a predetermined area and at the same time produce the intensity required to attain planned management objectives.

Prescribed burning is an important tool utilized by foresters to prepare sites for tree planting. These controlled burns accomplish several goals, such as:

- 1) Exposing the mineral soil to improve the quality of the planting job.
- Disposing of logging slash, thus improving access and allowing the planting crews easier mobility on the site.
- 3) Recycling nutrients, making them available for the next timber crop.
- 4) Manage competing vegetation and undesirable natural pine seedlings remaining on the site.
- 5) Improve wildlife habitat and enhance the appearance of the site.

During this burning season, the south and central districts managed by Billy Thurmon, and the north district managed by Keith Newsom have a combined total of over 2000 acres to be prescribed burned.

The Green End produced 23,542,731 3/8 ftg, the Dryers produced 23,658,324 3/8 ftg, and the Press produced 14,227,436 3/8 ftg. The Green End Shift I produced a record 450,930 (3/8 ftg) 1/8th veneer in one shift. A hearty congratulations goes out to all the hard working employees at Pollock that continue to strive for excellence.

Also, during the second quarter, we selected two Grant Parish High School students as recipients of Hunt Plywood's \$1,000 College Scholarships. Charles Fletcher and Lana Breland were chosen from a number of very impressive applicants.

LATHE PROJECT

A PLC upgrade and Bosch valve conversion were completed in the first two quarters of this year. The third and final phase of the project will be a lathe ratio conversion, core drive partial-lift, jackladder modifications, and charger replacement. These modifications will increase the lathe's ability to cycle blocks, thus improving the production capabilities of small blocks.

With these improvements, the Green End should be able to keep up with the dryers even if block diameters decrease dramatically. This will be a boost to the overall efficiency of the plant by increasing our wood utilization, while maintaining our production levels.
